1. Welcome and opening of the meeting

The Co-Chairs, D.I. Flatraaker and P. Spittler, opened the meeting at 9h00 and welcomed the participants to the 39th Plenary meeting which was held as a Teams meeting.

2. Roll call of delegates

A roll call of participants was held and the list of participants and apologies may be found in Annex 1. A new observer, on behalf of Eurosystem, Li-Chun Yuan of the Banque Centrale du Luxembourg was welcomed in replacement of A. Madeline.

3. Approval of the agenda

The draft agenda for the meeting (MSG MSCT 009-23v0.2) was presented on screen and subsequently approved.

4. Approval minutes 38th meeting

5. Status on submission of EPC 193-22 to ISO TC 68 SC 9

The Secretariat presented some slides (MSG MSCT 014-23) on the status of the submission of the document *Specification of QR-codes for MCTs in ISO format* (EPC193-22v1.2) by the EPC to ISO TC 68 SC 9 for fast track procedure. She explained that subsequent to the 2nd informal ballot held within the committee, the EPC has contacted representatives of the European countries who abstained from voting during this informal ballot. Since feedback was received that most of them already decided to cast a positive vote during the DIS (Draft International Standard) ballot on the document, the EPC decided to proceed with the ISO fast track procedure. The Plenary further received an insight into the voting rules for such DIS ballot and the ISO TC 68 SC 9 P-members having voting rights.

Nexo offered to send a letter to ISO TC 68 SC 9 expressing their support for the publication of the document as an International Standard, once the DIS ballot would be launched. The Co-Chairs expressed their appreciation for this support.

6. Preparation 3rd release MSCT IG

As agreed during the last Plenary meeting, a dedicated work-stream (WS) was established to start the preparation of the 3^{rd} release of the document on Mobile Initiated SEPA (Instant) Credit Transfer Payments and Interoperability Guidance (MSCT IG – EPC269-19v2.0). The WS held meetings on 6 February and 6 March 2023 respectively for which the agenda's and reports were shared with the Plenary prior to the meeting.

Since no specific questions related to these documents were raised, the Secretariat proposed to review the proposed updates to the document as described in MSG MSCT 003-23. She further explained that already a first meeting was scheduled of the WS Risk & security on 16 March 2023 to start the review of the security related chapters.

The Plenary was further informed that the WS in the meanwhile developed a new document (MSG MSCT 011-23), regrouping all the MSCT use cases developed by the MSG MSCT, including those contained in the document on *Interoperability of MSCTs based on NFC or BLE* (EPC287-22), which is currently under public consultation on the EPC website. The new document contains also a table reflecting the main characteristics for each MSCT use cases. It was explained that the WS briefly discussed a possible deletion of some MSCT use cases but finally decided to keep all of them. This decision is based on the fact that MSCTs are in an early stage of market adoption and that the further market evolvement will show over time which MSCT use cases will become the most important ones.

The Secretariat further explained that some of the "earlier" MSCT use cases are still under review in the WS with respect to the potential impact of the EBA answers received on the EBA Q&A posted by the MSCT IG (see MSG MSCT 009-22). The WS also discussed and agreed on the next steps and concrete actions for the updates to the Chapters 1 to 15.

7. EBA Clarification on Application of SCA to Digital wallets under PSD2

The EBA Clarification on Application of SCA to Digital wallets under PSD2, published by the EBA on 31 January 2023, was shown on screen and briefly reviewed. The Plenary was of the opinion that, although only card payments are mentioned in this statement, the requirements and guidance would also be applicable to mobile account based payments. It was agreed to further investigate this and possibly try to receive an informal answer from the EBA. The following AP was tabled.

Next, the Secretariat explained that the WS on the 3rd edition of the MSCT IG, has already analysed the EBA answers on the six EBA Q&A referenced in this statement. They also discussed the impact on the MSCT IG as presented in the report of the meeting held on 6 March 2023 (MSG MSCT 010-23). The six EBA answers and their impact on the MSCT IG would be further analysed during the next meeting of the WS Risk & security.

8. Liaison and monitoring

ECSG

The Plenary was informed by J.-P. Joliveau that the Belgian royal decree concerning the expansion and name change of the ECSG was recently published. The organisation would from now on be called European Payments Stakeholders Group (EPSG).

He further explained that the Transition Task force held their first meeting and agreed to review the work, amongst others, of the MSG MSCT. The Secretariat informed that she was invited to the next meeting of this TF on 13 March 2022 to provide a presentation on the work of the MSG MSCT.

Nexo

The Plenary was informed by J.P. Joliveau that nexo defined their strategy till 2027 and instant payments at the POI is one of the three main topics identified in this exercise. In view of the nexo scope extension, the Mobile Acceptance WG was revived and it was agreed that they should work on any new standard that would be needed in that respect. He further explained whereas nexo mainly focused on ISO 20022 messages, they would now also address JSON APIs.

elDAS2.0

The Plenary was informed about the recent publication of the *European Digital Identity Architecture and Reference Framework* – version 1.0. The eIDAS expert group adopted this document on 22 February 2022 and decided to publish it for stakeholder feedback.
